I, the above named person being eighteen or older in age, or the legal guardian of the above named person who is under 18, in consideration of the services provided by Central Baptist Church Owasso (CBCO), the rate charged for those services, and the right to engage in this activity as a participant and/or volunteer, hereby acknowledge, agree, promise and covenant with CBCO, its agents, employees, members, managers, officers, and directors on behalf of myself, my heirs, assigns, personal representatives and estate as follows:

ACKNOWLEDGE OF RISKS:

I UNDERSTAND AND ACKNOWLEDGE that the activity I am about to voluntarily engage in as a participant and/or volunteer bears certain known and unanticipated risks which could result in INJURY, DEATH, ILLNESS OR DISEASE, PHYSICAL OR MENTALDAMAGE to myself, to my property, or to spectators or other third parties. These risks include but are in no way limited to the following:

- 1) The risks which are inherent in the activities of skating, skateboarding, inline skating, roller skating, roller blading, including, but not limited to falling, coming in contact with ramps, walls, other equipment or persons;
- 2) The acts or omissions or negligence in any degree of CBCO, or its directors, officers, partners, members, managers, agents, or employees (collectively the Released Parties).
- 3) Latent or apparent defects or conditions in equipment or property supplied by CBCO, or other persons or entities.
- 4) The condition of any ramps and accidents connected with their use.
- 5) My own physical condition or my own acts or omissions.
- 6) First aid, emergency treatment or other services rendered by CBCO, or others.
- 7) Consumption of any food or drink, whether or not provided by CBCO, or others, and untreated water from the environment.

I UNDERSTAND AND ACKNOWLEDGE that the above list is not complete or exhaustive, and the other risks, known or unknown, identified or unidentified, anticipated or unanticipated may also result in injury, death, illness, disease or damage to myself or to my property or to spectators or other third parties.

ACCEPTANCE OF RISK AND RESPONSIBILITY:

I VOLUNTARILY AGREE, COVENANT AND PROMISE TO ACCEPT AND ASSUME ALL RESPONSIBILITIES AND RISK FOR INJURY, DEATH, ILLNESS, OR DAMAGE to myself or to my property arising from my participation in this activity. My participation in this activity is purely voluntary; no one is forcing me to participate in spite of the risks.

RELEASE:

I VOLUNTARILY RELEASE AND FOREVER DISCHARGE AND COVENANT NOT TO SUE ANY OF THE RELEASED PARTIES, from or for any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my participation in this activity, including, but not specifically limited to any and all negligence, fault or strict liability of any RELEASED PARTIES for any and all injury, death, illness or disease, and damage to myself or to my property. I FURTHER, AGREE, PROMISE AND COVENANT TO HOLD HARMLESS AND TO INDEMNIFY EACH OF THE RELEASED PARTIES from all defense costs, including attorney fees, or from any other costs incurred in connection with claims for bodily injury or property damage which I may negligently or intentionally cause spectators or other third parties in the course of my participation in this activity. I FURTHER AGREE, PROMISE AND COVENANT NOT TO USE, assert or otherwise maintain any claim against ANY OF THE RELEASED PARTIES, for any injury, death, illness and disease, or damage to myself or to my property, arising from or connected with my participation in this activity or from any claims asserted against

me by spectators or other third parties. **IN SIGNING THIS DOCUMENT, I FULLY RECOGNIZE THAT IF ANYONE IS HURT OR DIES, OR PROPERTY IS DAMAGED WHILE I AM ENGAGED IN THIS ACTIVITY, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST ANY OF THE RELEASED PARTIES EVEN IF ANY OF THE RELEASED PARTIES NEGLIGENTLY CAUSED THE BODILY INJURY OR PROPERTY DAMAGE.**

ACKNOWLEDGEMENT OF EFFECT OF THIS RELEASE AGREEMENT:

I UNDERSTAND AND ACKNOWLEDGE that by initiating and/ or signing this document I have given up certain rights and/ or possible claims which I might otherwise assert or maintain against the Released Parties, including specifically, but not limited to, rights arising from or claims for the acts or omissions, fault, negligence in any degree of any of the Released Parties. I understand and acknowledge that by initiating and/ or signing this document, I have assumed responsibility and LEGAL LIABILITY for the claims or other legal demands, including defense costs, which may be asserted by spectators or other third parties against me as a result of my participation in this activity.

PARTICIPANT INSURANCE BENEFITS AND REPRESENTATION OF PHYSICAL CONDITIONS:

I UNDERSTAND AND ACKNOWLEDGE that no major medical insurance benefits will be provided to me during this activity. I certify that I have sufficient health, accident, and personal liability insurance to cover any bodily injury, property damage or disablement that may occur while participating in this activity, and to cover bodily injury or property damage caused to a third party as a result of my participation in this activity. If I have no such insurance, I certify that I am capable of personally paying for any and all such expenses or liability. I FURTHER ACKNOWLEDGE that the undersigned is in good physical and mental health, and not suffering from any condition, disease or disablement, which would or could potentially affect participation in this activity.
